Migration Specification for Employer Responsive ILR data collection and ESF short record data for 2010/11

- 1 This appendix describes the rules for migrating Employer Responsive and ESF short record format ILR data from 2009/10 to Employer Responsive ILR data and ESF short record, respectively, for 2010/11.
- 2 The data transformations indicated in this specification are written from the perspective that all fields are mapped to their new 10/11 values at the same time and are not processed sequentially. The mappings for the fields use the 09/10 values to determine the new 10/11 values.
- 3 This appendix has the following sections:
 - Section A describes the migration rules for employer responsive ILR data and is split into two parts:
 - Part 1 – the learner data set
 - Part 2 – the learning aim data set (all learning aims including programme aims)
 - Section B describes the migration rules for ESF short record data.
 - Section C contains a flowchart to show in more detail rule A69 for employer responsive funded ILR data
- 4 Information will be provided for transfers between providers or local SFA or local YPLA regions that indicate which provider number and contracting organisation code the data should be migrated to.
- 5 From 2010/11 the Sources of funding field, field A11, has been added to the employer responsive and ESF SR collections, and needs to be completed for all learning aims. For migration the code in field A11 will be based on the funding stream recorded in field A10.
- 6 Any learning aims which have a Learning aim start date of on or after 1 August 2010, the learning aims will not be migrated and these aims will have a number of validation errors. These errors will be due to the learners not having the correct fields completed as they were completed in 2009/10, particularly if the field has been introduced in 2010/11.

Section A

Migration of 2009/10 employer responsive providers data

Apprenticeship Programmes

For apprenticeship programmes, the following learner and learning aim records (including programme aims) should be migrated:

- all learner records which have at least one learning aim where the actual end date field A31 = null; and
- all learner records which have at least one learning aim where the learning actual end date, field A31 is not null but A40=null and A35=(4 or 5); and
- all learning aim records where the actual end date field A31 = null; and
- all learning aim records where the learning actual end date, field A31 is not null and the learner has at least one open aim with the same Provider number A01, Learner reference number A03, Programme type A15 and sector framework code combination A26; and
- all learning aim records where the learning actual end date, field A31 is not null and the learner has at least one learning aim where A40=null and A35=(4 or 5) with the same Provider number A01, Learner reference number A03, Programme type A15 and sector framework code combination A26

Train to Gain and other learning aims

For other employer responsive learning aims, the following learner and learning aim records should be migrated:

- all learner records which have at least one learning aim record where the actual end date field, field A31 = null; and
- all learning aim records where the actual end date field A31 = null; and
- all learner records and learning aim records where the learning actual end date, field A31 is not null and A40=null and A35=(4 or 5)
