Appendix P – Data quality, standards and field ownership

Introduction

This Appendix is split into 2 sections; Part A – Data Quality and Standards and Part B – Data Owner, Main Stakeholders and Main data uses. More information on each section can be found below.

Part A - Data Quality Standards

The information authority board has requested the secretariat to develop common data standards. One response to this request is to develop and publish data quality standards for the data collected through the individualised learner record (ILR).

This appendix is the first step to developing and publishing comprehensive data quality standards. At this stage the data quality standards are rudimentary. They give a provider a way of assuring itself that the data it prepares is fit for the purposes for which it is requested. With time the standards will be refined so that those stakeholders using ILR data can place increasing confidence in it and that it is adequate to meet their needs.

In the future where a stakeholder wishes to use existing ILR data for a new purpose it will be able to use these data quality standards to identify whether the ILR as it stands is capable of supporting their requirement. Where a stakeholder identifies that the data quality standard does not meet its requirement it will be able to make a request for change which will be processed in the normal way by measuring it against the ILR change criteria.

Part B - Data Owner, Main Stakeholders and Main Data Uses

The information authority board has requested the secretariat to map the data collection and analysis process, that is to document what data is collected, for which reports and how the data is analysed. This appendix is a step towards meeting that request.

The appendix identifies for each field in the individualised learner record (ILR) a data owner, one or more main stakeholders and the main data uses.

The data owner is the organisation which is the main requestor and user of the data collected in a particular data field. Often it is the data owner that made the original request to include the field in the ILR specification. The secretariat would check that any request it received to change the specification of a field was supported by the data owner.

A main stakeholder is any organisation which makes extensive use of and relies on the data in a data field and is not itself the data owner. The secretariat would check with a main stakeholder it was content with the impact on it of any request to change the specification.

The main data use section is used to identify for each field where it makes a significant contribution to:

- general data analysis – this includes statistical first releases and other significant stakeholder internal and external descriptive MI
- LSC funding – used in the funding calculations, provider factors or in setting rates for future years
- planning – used in the process for agreeing what provision is procured in the year ahead
- provider performance management – used to monitor delivery against plan
- surveys – used to drive surveys of learners
- equality and diversity – used to monitor equality and diversity
- other – as described in the additional information section.

Most fields are used in a whole range of reporting. Consequently it would not be particularly helpful to describe all the places a field is used in reporting. Instead this table identifies where a particular reporting requirement depends significantly on a field.
